## Introduction

AT Global Markets LLC is a Limited Liability Company registered in Saint Vincent and the Grenadines under company number 333 LLC 2020. The registered office is located at 1st Floor, First St. Vincent Bank Building, James Street, Kingstown, St. Vincent and the Grenadines.

ATFX is excited to announce the "Jingle Your Way to Bigger Rewards: Triple Up and Win a Trip to Hong Kong!" promotion (hereinafter referred to as the "**Promotion**") and invites all new and existing ATFX clients in Thailand to participate. By taking part in this Promotion, you agree to be bound by the following Terms and Conditions (hereinafter referred to as the "**Terms**").

# 1. Interpretation of Terms

1.1 In this Promotion, the following terms shall have the meanings assigned below:

"Account" shall refer to any new or existing client who makes a net deposit into their ATFX account during the Promotion Period.

**"Minimum Net Deposit"** shall mean that the client must make a net deposit of \$1,000 USD or more to participate in this campaign.

**"Promotion Period"** shall mean the period from 1st October 2024 (00:00) to 31st December 2024 (23:59), inclusive.

**"Standard Terms of Business"** shall refer to the Terms and Conditions agreed upon by the Client and ATFX that govern all trading activities of the Client with ATFX.

- 1.2 Any terms not defined herein shall have the meanings provided in **the Standard Terms of Business.**
- 1.3 All times mentioned herein shall be in **GMT +7**.

## 2. Eligibility Criteria

- 2.1 To participate in this Promotion, you must meet the following requirements:
  - (a) You are a registered and approved client of ATFX in Thailand, eligible to trade in accordance to, and have agreed to, the Standard Terms of Business;
  - (b) Run a live trading account (meaning, not a "demo" account) with ATFX as per the applicable requirements of ATFX
  - (c) Make a minimum net deposit(s) of \$1,000 USD



### 3. Duration

3.1 The Promotion Period starts at 00:00 on 1st October 2024 and ends at 23:59 on 31st December 2024 (TH Time).

# **4. Specific Program Terms**

- 4.1 All new and existing clients who register for this campaign are eligible.
- 4.2 The Promotion is applicable to the MT4 and MT5 accounts.
- 4.3 Account types Standard, Edge, VIP, ECN and Master CopyTrade can participate, except for PAMM, MAM, and Follower CopyTrade accounts.
- 4.4 Lots can be counted in all products except Share CFDs, Cryptocurrencies, and ETFs.
- 4.5 The full lots will be counted from all eligible accounts under the same name.
- 4.6 Top Trader Rewards:

### Note:

- a. The net deposit and lot size indicated are the minimum requirements to qualify for each tier.
- b. Participants must rank among the top traders in term of net deposit by 23:59 on December 31, 2024 (GMT+7) to be eligible for the prizes.
- c. In case the total net deposit amounts are equal among the top traders, the number of lots will be the second criterion considered.



## 4.7 Lucky Draw to Hong Kong:

To enter the lucky draw, participants must have a minimum of 100 tickets and a net deposit of 10,000 USD to qualify for the prize pool. One lot equals one ticket. The more tickets you accumulate, the higher your chances of winning the lucky draw. There will be 3 prizes:

  - 3 smartwatches (Apple, Samsung, Garmin)
- 4.9 All prizes will be calculated after the campaign ends and will be presented to qualified clients before 31 January 2025.

# **Examples below:**

# **Example 1: Diamond Tier Reward and Hong Kong Lucky Pool**

- Scenario:
  - Mr. B is an existing client. He has a Standard account and wants to participate in both the Top Trader Rewards and the Hong Kong Lucky Pool.
- Steps Taken:



- In October December 2024, Mr. B made a net deposit of \$155,000 USD into his ATFX account.
- He then traded 100 lots of EURUSD within the Promotion Period.

#### Outcome:

- Top Trader Rewards:
  - Mr. B qualifies for the Diamond Tier by meeting the requirements of a net deposit of over \$10,000 and trading 50 lots or more. He will receive one Agoda Pass worth 10,000 THB if he remains in the top 5 of this tier until the end of the campaign.
- Lucky Draw to Hong Kong:
  - With 100 tickets, Mr. B qualifies for the Grand Prize draw, which is a trip to Hong Kong for two people, including flights, hotel accommodations, and Disneyland tickets. Only one prize is available for this Grand Prize.
  - Additionally, if Mr. B misses out on the Grand Prize to Hong Kong, he will still have a chance to win in the secondary prize draw, where he could win either a new iPhone 16 128GB or an iPad Pro 11-inch Wi-Fi 256GB.

## **Example 2: Gold Tier Reward and Lucky Draw**

#### Scenario:

Ms. C is a new client who wants to participate in the Top Trader Rewards and Lucky Draw.

### Steps Taken:

- $_{\odot}$  On 15th November 2024, Ms. C opens a new VIP account with ATFX, reads and accepts the Terms and Conditions.
- She has a net deposit of \$7,500 USD and trades 35 lots of GBPUSD within the promotion period.

#### Outcome:

- Top Trader Rewards:
  - Ms. C qualifies for the Gold Tier by having a net deposit between \$5,000 and \$9,999 and trading at least 30 lots. She will receive one Air ticket worth 7,000 THB if she remains in the top 5 of this tier until the end of the campaign.

### **Example 3: Only ATFX Santa's Giveaway Participation**

## Scenario:

Mr. F is a new client only interested in the ATFX Santa's Giveaway.

### Steps Taken:



- o On 20th December 2024, Mr. F opens a Standard account with ATFX.
- He deposits \$1,000 USD, likes, and shares the ATFX posts publicly, using the hashtags #ATFXJingleYourWay2024 and #ATFX.

### Outcome:

## ATFX Santa's Giveaway:

 Mr. F is eligible to enter the giveaway since he has made a deposit during the campaign and completed the required social media actions. He has a chance to win one of the 3 smartwatches (Apple, Samsung, Garmin).

### 5. Miscellaneous

- 5.1 The Client's withdrawal requests shall be processed normally during the Active Period mentioned in clause 1.1 above herein subject to the Standard Terms of Business.
- 5.2 Only positions that were opened and closed during the promotion period mentioned in clause 1.1 above herein will be eligible in accordance with the current "Jingle Your Way to Bigger Rewards: Triple Up and Win a Trip to Hong Kong!" Promotion T&Cs.
- 5.3 ATFX, in its sole and absolute discretion, shall have the right to approve and/or exclude Clients of Introducing Brokers of ATFX as these may participate in accordance with the current "Jingle Your Way to Bigger Rewards: Triple Up and Win a Trip to Hong Kong!" Promotion T&Cs.
- 5.4 In the event that any dispute and/or misrepresentation is made in relation to the above applicable Terms, such dispute and/or misrepresentation shall be resolved by ATFX, acting in good faith and as it shall, in its sole and absolute discretion, be deemed fit and proper. ATFX's decision shall be final and binding.
- 5.5 ATFX has the right to disqualify any Client who has accepted the current "Jingle Your Way to Bigger Rewards: Triple Up and Win a Trip to Hong Kong!" Promotion T&Cs:
  - (a) A breach of these Terms and/or any term of the Standard Terms of Business occurs;
  - (b) ATFX has reasonable grounds to believe there is a valid misuse of this Promotion;
  - (c) The Client acts in bad faith and/or abusively and/or fraudulently and/or in a manner that is not in line with this Promotion and its applicable Terms;
- 5.6 ATFX has the right to alter these Terms at its absolute discretion and to suspend and/or terminate the Promotion if its continuation is rendered impossible due to extraordinary circumstances beyond the control of ATFX (natural disasters, political conflicts etc.).
- 5.7 By accepting the current Terms, the Client acknowledges that he/she has read and agreed to be bound by these Terms together with the Standard Terms of Business as well as to all other Business terms and conditions as these may be applicable and/or amended from time to time.



5.8 Notwithstanding the translated language of this document, the English wording shall be the binding version in the event of any discrepancy between the two languages.
