TERMS & CONDITIONS

April 2025



ATFX is a trading name of AT Global Markets LLC (company number 333 LLC 2020), which is a Limited Liability Company in Saint Vincent and the Grenadines. The Registered Office: 1st Floor, First St. Vincent Bank Bldg, James Street, Kingstown, St. Vincent and the Grenadines.

ATFX is running the "**ATFX CopyTrade All-Star Game 2025**" (hereinafter referred to as the "**Promotion**") and invites all eligible Clients of ATFX to participate. This promotion is not available to clients in China. By joining this Promotion, participants agree to be bound by these **Terms & Conditions** (hereinafter referred to as the "Terms") as set out below.

1. Interpretation of Terms

1.1. In this Promotion:

"Account" shall mean a trading account with ATFX whereby the Client registers and deposits in accordance with Minimum Deposit before the end of the Promotion Period in accordance.

"Provider Account" refers to an ATFX CopyTrade Provider account used for sharing trading strategies.

"Follower Account" refers to an ATFX CopyTrade Follower account used for copying trades from Providers.

"Minimum Deposit" shall mean any amount which is equal to or in excess of US\$100 or equivalent. All accounts shall be enabled and/or approved for trading given that they comply with the stipulated eligibility criteria.

"**Promotion Period**" shall mean from April 1, 2025 (00:00 GMT+8) to June 30, 2025 (23:59 GMT+8) (inclusive).

"ATFX Customized Promotion Package" refers to the promotional support given to winners, including marketing exposure and featured content on ATFX platforms. The package cannot be converted into cash refunds. If a winner chooses to forfeit the package, ATFX reserves the right to select another participant to receive the benefit.

"Standard Terms of Business" shall mean the Terms and Conditions governing all trading activity between the Client and ATFX.

1.2. Any undefined terms shall have the meaning provided in the Standard Terms of Business.

1.3. Times mentioned herein shall mean GMT +8 as applicable.

2. Eligibility Criteria

- 2.1. All new and existing Providers and Followers will automatically be enrolled in this Promotion, provided they meet the following criteria. Clients are eligible to win prizes in both Game 1, Game 2, and Game 3. A client may qualify and win a prize in each game independently, provided they meet the individual requirements and criteria for each respective game.
- 2.2. To participate in this Promotion, you will be required to fulfil the following requirements: 2.2.1. Providers:
 - 2.2.1.1. Must create an offer to be eligible for participation.
 - 2.2.1.2. Must have at least 10 followers.
 - 2.2.1.3. Must trade at least 20 lots during the Promotion Period.
 - 2.2.1.4. Must comply with ATFX trading policies.
 - 2.2.2. Followers:
 - 2.2.2.1. Must subscribe to an offer, activate the subscription and start copying during the Promotion Period.
 - 2.2.2.2. Must deposit a minimum of US\$100 to participate in the promotion.
 - 2.2.3. Participants must not be employees or relatives of employees of ATFX.
 - 2.2.4. ATFX is entitled to verify the data of the Client by requesting from the Client presentation the ID Card with national information, the phone, email and proper documents which would confirm: the address being entered in the proper register, authorization to represent the natural person or organization unit, as well as to enter into obligations on his/her behalf for a person registering to the ATFX Account, and contact data such as phone number or email address;
 - 2.2.5. Read and Accept the Terms of this Promotion.
- 2.3. Prizes: Participants who meet the challenge requirements will receive the following prizes:

2.3.1. For Providers:

- 2.3.1.1. Game 1: Return Rate Leader
 - a. During the Promotion Period, The Provider with the highest return rate will be awarded the prizes below:

2 nd Place	US\$1,000	Certificate
3 rd Place	US\$800	Certificate

Example: If Provider A achieves an average return rate of 35% while Provider B achieves 30%, Provider A will be the winner.

- b. In Game 1, if more than one Provider achieves the same prize placement, the Rewards will be equally divided among all the winners in that respective prize category. Providers should proactively review their number of followers in the Client portal.
- 2.3.1.2. Game 2: Follower Growth Champion
 - a. During the Promotion Period, The Provider with the highest number of net new Followers will be awarded the prizes below:

Example 1: If a Provider starts with 100 followers on April 1st and has 120 followers by June 30th, the growth of followers is 20.Example 2: If there are two winners for the 3rd prize, each winner will receive USD 250.

- b. In Game 2, if more than one Provider achieves the same prize placement, the Rewards will be equally divided among all the winners in that respective prize category. Providers should proactively review their number of followers in the Client portal.
- 2.3.1.3. Game 3: Top Influencing Provider
 - a. Awarded to the Provider with the most engagement, <u>which may</u> <u>include</u>, <u>but is not limited to</u>, the following situations of online engagement:
 - i. Active participation in social media platforms, such as sharing trade insights, promotional content, or educational material related to trading.
 - ii. Interactions and responses to followers or community members across social media platforms (e.g., Facebook, Twitter,



Instagram, YouTube, TikTok, etc.).

- iii. Live streaming or podcasts of trading sessions, market analysis, or Q&A sessions to engage with followers.
- iv. Creating and sharing content that encourages community growth, such as blogs, videos, or educational articles.
- b. ATFX reserves the right to **determine** the winner based on the highest engagement level across social networks.

2.3.2. For Followers:

- 2.3.2.1. Build Your Star
 - a. Only followers who are subscribed to the Top 3 Return Rate Leaders or Top 3 Follower Growth Champions at the end of the Promotion Period will be entered into the lucky draw.
 - b. Each client is eligible for one chance to participate in the lucky draw, regardless of the number of providers they follow.

3. Duration

4. Specific Program Terms

- 4.1. The Promotion is applicable to ATFX CopyTrade Provider & Follower accounts only.
- 4.2. It is understood that the Cash Reward is to be disbursed to the Account.
- 4.3. Only positions opened and closed during the Promotion Period will be counted toward the required trading lots.
- 4.4. All trading activity must be completed with the Account within the promotion period to



- 4.5. Transfers between accounts are not considered as deposits for the purposes of participating in this promotion.
- 4.6. Winners agree to the publication of their names and photos in the ATFX news, social pages and/or other media medium.
- 4.7. Each participant agrees that his or her registration data (including but not limited to country of residence) will be published at atfx.com, the company's official social pages and/or other media medium.
- 4.8. Contest participation is not open to ATFX's employees or their relatives.

5. Miscellaneous

- 5.1. In the event that any dispute and/or misrepresentation is made in relation to the above applicable Terms, such dispute and/or misrepresentation shall be resolved by ATFX, acting in good faith and as it shall, in its sole and absolute discretion, be deemed fit and proper. ATFX's decision shall be final and binding.
- 5.2. ATFX has the right at any time and its absolute discretion to disqualify any Client who participates in the Promotion and/or withdraw with immediate notice the Trading Credit and/or any profit gained if:
 - 5.2.1. A breach of these Terms and/or any term of the Standard Terms of Business occurs.
 - 5.2.2. ATFX has reasonable grounds to believe there is a valid misuse of this Promotion.
 - 5.2.3. The Client acts in bad faith and/or abusively and/or fraudulently and/or in a manner that is not in line with this Promotion and its applicable Terms.
- 5.3. If any clients introduced to ATFX by Introducing Brokers misuse of this Promotion to gain the welcome bonus, the commission to the relevant Introducing Brokers would be cancelled.
- 5.4. ATFX shall not be held liable for any margin call or losses that the client may suffer, including but not limited to losses due to Stop-out Level, if the Trading Credit is withdrawn for any reason pursuant to the Terms and Conditions set out herein.
- 5.5. ATFX reserves the right to alter these Terms at its absolute discretion and to suspend and/or terminate the Promotion if its continuation is rendered impossible due to extraordinary circumstances beyond the control of ATFX (natural disasters, political
