



ATFX Substitute Your Trade Promotion (Thailand)

Terms & Conditions

July 2026



Introduction

AT Global Markets LLC is a Limited Liability Company in Saint Vincent and the Grenadines with company number 333 LLC 2020. The Registered Office: 1st Floor, First St. Vincent Bank Bldg, James Street, Kingstown, St. Vincent and the Grenadines.

ATFX is hosting the “**Substitute Your Trade**” Promotion (hereinafter referred to as the “Promotion”) and invites all eligible ATFX clients to participate. By participating in this Promotion, you agree to be bound by these Terms and Conditions (hereinafter referred to as the “Terms”) as set out below.

1. Interpretation of Terms

- “**Account**” shall mean a client's new or existing live trading account registered and designated by ATFX.
- “**Balance Bonus**” shall mean the 1% Balance Bonus awarded to eligible clients based on the qualifying deposit/top-up amount and verified previous broker withdrawal amount, subject to a maximum amount of USD 500.
- “**Promotion Period**” shall mean the period from 1 July 2026 (00:00) to 30 September 2026 (23:59), inclusive (GMT+7).
- “**Trading Requirement**” shall mean the minimum trading volume required to remove the withdrawal and internal balance transfer restrictions.
- “**Standard Terms of Business**” shall mean the Terms entered by the client and ATFX that govern all trading activities between the client and ATFX.

All other terms not defined herein shall have the meaning set out in the Standard Terms of Business. Times mentioned herein shall mean GMT+7 as applicable.

2. Duration

The Promotion Period will start from 1 July 2026 (00:00) to 30 September 2026 (23:59), inclusive (GMT+7).

3. Eligibility and Participation Criteria

1. Be a new or existing ATFX client and have agreed to the Standard Terms of Business;
2. Successfully complete KYC verification;



3. Have Thailand as their country of residence in order to participate in this Promotion;
4. New clients must make a minimum deposit of USD 100;
5. Existing clients must make a minimum top-up of USD 100. Internal transfer is not accepted;
6. Submit valid proof of withdrawal from the previous broker dated from 15 June 2026 onwards;
7. ATFX will validate the withdrawal proof before approving the Balance;
8. Only local currency deposit channels are eligible for this Promotion.

4. Balance Bonus

1. Eligible clients may receive a 1% Balance Bonus. The Balance Bonus will be calculated based on 1% of the lower amount between the verified withdrawal amount from the previous broker and the deposit/top-up amount made to ATFX.
2. The maximum Balance Bonus available per client is USD 500.
3. Clients may submit multiple claims under this Promotion, provided that valid proof of withdrawal is submitted for each claim. Each proof of withdrawal may only be used in relation to one qualifying deposit/top-up.

Example of the 1% Balance Bonus Calculation:

Previous Broker Withdrawal Amount	Deposit / Top-up Amount in the Trading Account	Balance Bonus Amount
USD 10,000	USD 10,000	USD 100
USD 9,000	USD 10,000	USD 90
USD 10,000	USD 9,000	USD 90
USD 50,000	USD 50,000	USD 500

5. Withdrawal Restriction and Trading Requirement

1. After the Balance Bonus is credited, the client's trading account will be restricted from withdrawals and internal balance transfers until the Trading Requirement is completed or the client cancels participation in the Promotion.
2. The client must complete the Trading Requirement within 90 calendar days from the date of registering for this Promotion. If the client fails to complete the Trading Requirement within 90 calendar days, the Balance Bonus will be cancelled.

USD 101–200	1.0 lots
USD 201–300	1.5 lots
Above USD 301	2.0 lots

6. Specific Program Terms

1. This Promotion applies to CFDs, Forex, precious metals, commodities, indices and futures offered by ATFX.
2. Cryptocurrency CFDs and shares CFDs are excluded from this Promotion.
3. The Balance Bonus is tradable but cannot be withdrawn until the client fulfils the eligibility criteria and Trading Requirement.
4. The Balance Bonus will be credited approximately within 1 working day after ATFX confirms the validity of the withdrawal proof.
5. Participation in this Promotion is not open to ATFX employees or their relatives.

7. Miscellaneous

1. ATFX reserves the right to disqualify any client and/or cancel the Balance Bonus if the client breaches these Terms and/or the Standard Terms of Business, ATFX reasonably believes there is misuse of this Promotion, or the client acts in bad faith, fraudulently, or inconsistently with this Promotion.
2. ATFX reserves the right to amend these Terms at its discretion and suspend and/or terminate the Promotion where necessary.
3. Notwithstanding any translated version of this document, the English version shall be the binding version in case of discrepancy.
